



**Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing, the wearing of cloth face coverings, and have, in many locations, prohibited the congregation of groups of people.

**The Boy Scouts of America, Central NC Council, the leadership of your Unit (Pack, Troop, Crew or Post), Unit's Chartering Organization and all subsidiaries thereof, here and after, collectively referred to as "CNCC"** have put in place preventive measures to reduce the spread of COVID-19; however, **CNCC cannot guarantee** that you or your child(ren) will not become infected with COVID-19. Further, **attending activities, functions and meetings of CNCC and aCNCC properties, including Camp John J. Barnhardt and Scout Service Center, could increase** your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I, the undersigned, acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending CNCC activities, as well as being present upon CNCC properties, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at CNCC activities and properties may result from the actions, omissions, or negligence of myself and others, including, but not limited to, CNCC employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur as a result of exposure to or infection by the COVID-19 virus as a result of or arising out of or in connection with my child(ren)'s attendance at a CNCC activity or property or participation in CNCC programming ("Claims"). On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and agree to indemnify and hold harmless the CNCC, its employees, volunteers, agents, representatives, and their respective heirs, successors and assigns from and against the Claims, whether now existing or hereafter occurring, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that the Claims released include any Claims based on the actions, omissions, or negligence of the CNCC, its employees, volunteers, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any CNCC activity or program.
